I.

9 Sept 08	20:44	1234 Yellow Brick Rd San Antonio, TX 78999	I spoke to Dopie, who identified himself as defendant's cousin. He said Mickey was a long haul trucker and would be back in a couple of weeks.
17 Sept 08	07:52	1234 Yellow Brick Rd San Antonio, TX 78999	There was no answer to my knocking or ringing of the doorbell. The external porch lights were on. The Weiner Mobile was parked in the drive.
23 Sept 08	11:49	1234 Yellow Brick Rd San Antonio, TX 78999	There was no answer to my knocking or ringing of the doorbell. No vehicles were present.
7 Oct 08	16:11	1234 Yellow Brick Rd San Antonio, TX 78999	I spoke to Minnie Mouse, the respondent's wife. She said that Mickey was not home and did not know when he would be back. She said he just switched companies and did not know what their schedule was yet.

IV.

For the reasons set forth above, it is impractical to secure personal service on Defendant, [Mickey Mouse](#), and I will be unable to do so despite due diligence. Therefore, substituted service is necessary and I believe [Mickey Mouse](#) will receive effective notice of this suit by leaving copies of the citation and the attached petition with anyone over the age of sixteen (16) years at [1234 Yellow Brick Rd, San Antonio, TX 78999](#) or by attaching the citation with the petition attached, to either the front door, side door, back door, gate and/or fence of the residence and/or business located at [1234 Yellow Brick Rd, San Antonio, TX 78999](#).
